The Social Security Administration will mail them back at the end of the application process.

**Survivors Benefits** When a worker dies, the Social Security Administration provides their family with survivor's benefits to help fill the income gap left behind. These come as both one-time and monthly payments. A worker must have earned at least six credits in the three years before his death for his family to
